

Revegetation Technician SKA-003

Summary:

This position is located in Moab, Utah. It is an annual full-time position that will support revegetation and general landscaping activities for a portion of the Moab UMTRA Project site from March through October.

Essential Duties and Responsibilities:

Duties and Responsibilities consist of but are not limited to the following:

- Transplanting shrubs, trees, and grasses.
- Control of noxious, invasive weeds through the application of herbicides and pesticides.
- Sprinkler system maintenance.
- Routine watering of vegetation.
- The ability to operate a weed cutter, chain saw, tractor, and motor vehicle.
- Provide support and data as requested for administrative purposes and in support of the Quality Management System
- Must perform other duties as assigned at the discretion of management

Supervisory Responsibilities:

This job will not have direct supervisory responsibilities.

Competency:

Must demonstrate ethics, responsibility, confidentiality, professionalism, punctuality and consistent dependability, organizational skills, the ability to perform multi-task productivity standards established, and work effectively as part of a team.

Qualifications:

To perform this job successfully, an individual must be able to perform each duty assigned thoroughly and independently, without supervision on short term projects. The requirements listed below are representative of the knowledge, skill, and/or ability required. Education and/or Experience:

- High school diploma and/or 2 years previous general landscaping experience. Previous additional work experience may be substituted for education requirement.
- Background in plumbing or sprinkler systems and knowledge of local plant species is desired.
